

MINUTES OF THE DDC MEETING HELD ON 08-04-2022 AT 10-30 AM IN THE CONFERENCE HALL, OFFICE OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF APRIL/2022 (.)

The meeting was held in presence of Heads of various Development Departments of the district and Chaired by Shri M.N. Baruah, ACS, Deputy Commissioner, Golaghat.

At the very outset the Deputy Commissioner, Golaghat welcomed the members present in the meeting and offered his best wishes for forthcoming "Bohag Bihu Festival". D.C. also gave a briefing about the minutes of the discussion held in the D.C.'s Conference Chaired by the Hon'ble Chief Minister, Assam at Administration Staff College, Guwahati on 5th April/2022 and action to be taken by the Heads of Development Department. The D.C. also informed about the proposed visit of the Hon'ble Prime Minister of India to Dibrugarh on 28th April/2022 and also the virtual foundation stone laying programme of proposed Golaghat Cancer Hospital etc. and accordingly he asked the heads of development department to extend their help and cooperation towards successful holding of the programme. The D.C. also asked the heads of development department not to leave head quarters without prior permission of the Deputy Commissioner.

After that the meeting discussed elaborately and emphasized on the following aspect.

- 1) Meeting discussed elaborately on land acquisition matters and D.C. asked the concerned heads to take immediate steps pertaining to their department.
- 2) Meeting discussed on the progress of proposed construction works of Dhodar Ali under Asom Mala.
- 3) Meeting discussion on the progress of construction works of PHG Path and shifting of water line and Electric Pool near PHG Path within the 8 mtrs. of PHG Path. Concerned departments will take immediate necessary steps.
- 4) District Level Purchase Committee Meeting relating to PWD Department will be held on 12/04/2022 and accordingly PWD Department will take necessary steps.
- 5) Meeting discussed on the progress of proposed integrated office building of D.C.'s Office, Golaghat and shifting of existing offices from the plan site to old court building.
- 6) Meeting discussed on construction of an additional circuit house at Golaghat. PWD (Building) will tie up the matter.
- 7) Meeting also discussed on renovation of Probin Gogoi Indoor Stadium, Golaghat.

- 8) Meeting discussed on proposed Golaghat Medical College.
- 9) Discussion were held on renovation of Golaghat District Library.
- 10) The Deputy Director Town and Country Planning, Golaghat will make proper coordination with PWD (Building) Division regarding implementation of schemes taken under CIDF.
- 11) During discussion on PWD Building Division, the D.C. stressed on the use of LED Bulb in the Govt. Offices and Govt. Buildings.
- 12) Meeting discussed on the progress of Urban Water Supply Scheme at Golaghat.
- 13) During discussion on Education Sector, D.C. stressed on proper coordination between Teachers, Students and parents. Meeting also discussed on forthcoming Gunotsav Programme.
- 14) The D.C. gave briefing in the meeting about Amrit Uddyan and Amrit Sarovr Scheme.
- 15) Meeting discussed on a possibility of a Mini Ethanol Plant in Golaghat District and accordingly GM, DI & CC will tie up the matter.
- 16) Meeting discussed on the progress of International Aagor Trade Centre at Dabidubi. DFO Golaghat and GM DI & CC will keep proper coordination regarding plantation at Dabidubi.
- 17) Meeting discussed on Paddy Procurement and PM Kishan Scheme.
- 18) During discussion on Court matter and RTI matter, D.C. asked the Heads of Development Department not to neglect any Court and RTI matter.
- 19) Regarding OMS, Addl. D.C. will make proper coordination with FCI.
- 20) Regarding collection of Revenue / Tax, concerned District Heads are directed to work hard for achieving the target.
- 21) Meeting discussed on the progress on the JJM scheme and the matter of non electrification of schools and AWCs of the district.
- 22) Irrigation Department will tie up with Soil Conservation Department and will assess the work done of Amguri Project.
- 23) Irrigation Department and NABARD will visit jointly the Dhodang on going project under Soil Conservation Department and submit a status report in the next DDC Meeting.
- 24) Regarding implementation of plantation scheme, Soil Conservation will tie up with Sericulture Department.
- 25) Regarding Development of Marshy Land with creation of pond at Kathkotia Village, Golaghat taken under Soil Conservation Department the District Fishery Development Officer, Golaghat will visit the project and submit a report in the next DDC meeting.
- 26) While discussing on Fishery Sector the D.C. stressed on proper implementation of Asom Fishery Act -1953.
- 27) During discussion on Employment Sector the District Employment Officer gave a briefing about the progress of Online Registration.

- 28) While discussing on Labour Sector, the Asstt. Labour Commissioner, Golaghat gave a briefing on the I-Shram Portal Registration Scheme, Pradhan Mantri Shram Yogi Mon Dhan Yojana , NPS Traders Scheme under Labour Department. In this regard the D.C. asked the ALC to give a power point presentation in the next DDC meeting. D.C. also asked the Supdt. H&T to tie up with Labour Department.
- 29) Progress of Weavers Mudra Loan Scheme, SAMARTH, SWA NIRBHAR NARI and Block Level Cluster under NHDP scheme were discussed in the meeting. Regarding disbursement of loan Supdt. of H&T will make proper coordination with LDM.
- 30) Meeting discussed on the progress of RKVY Scheme, RIDF Scheme, Rastriya Gokul Mission Scheme, National Livestock Mission and National Animal Disease Control Programme and Mission Goat Production scheme of Veterinary Department
- 31) While discussing on Irrigation Sector the D.C. asked the Executive Engineer, Irrigation to keep close touch with Agriculture Deptt. and Soil Conservation Department.
- 32) Regarding proper disbursement of PMEGP loan Industry Department will make proper and frequent communication with bank authorities.
- 33) The District Sports Officer will extend help and cooperation toward smooth implementation of sports related scheme under CIDF.
- 34) The next DDC Meeting for the month of May/2022 will be held on 5th May/2022.
- 35) As the present state government will complete one year in the month of May/2022 and accordingly the Heads of Development Department will prepare successful stories/ progress report pertaining to their department and will submit in the D.C.P. Branch, D.C.'s Office, Golaghat.
