

MINUTES OF THE DDC MEETING HELD ON 06-08-2022 AT 10-30 AM IN THE CONFERENCE HALL, OFFICE OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF AUGUST/2022 (.)

The meeting was held in presence of Hon'ble MLA, Dergaon LAC, District Development Commissioner, Golaghat, CEO, Zila Parishad Golaghat, SDO (Civil) Dhansiri and Bokakhat, Circle Officers and Heads of various Development Departments of the district and Chaired by Shri MN Baruah, ACS, Deputy Commissioner, Golaghat.

The list of participants are given in Annexure - I.

At the very outset the Deputy Commissioner, Golaghat welcome the members present in the meeting and offered his best wishes regarding forthcoming Independence Day and asked the members to extend their full cooperation for successful celebration of Independence Day as well as "Har Ghar Tiranga" Programme.

Initiating the discussion the Deputy Commissioner stressed on the proper coordination amongst the Development Department for successful implementation of the scheme and thereby achieving the target. The Deputy Commissioner stated that the Govt. has stressed on collection of Revenue / Tax. He also asked the concerned heads of development department to fulfill the target of "Azadi Se Antyadaya Tak" scheme. The DC also asked the Water Resource Deptt. to keep strict vigil on the vulnerable point to avert any flood situation prevailing like in other district of Assam. All heads of development department were also asked to be alert regarding flood.

Thereafter, the meeting discussed sector wise developmental schemes in detail and reviewed the action taken of the last minutes of the DDC as follows:-

- 1) Meeting discussed on collection of Revenue /Tax. Concerned District Heads are directed to work hard for achieving the target.
- 2) While reviewing the excise sector the Supdt. of Excise stated that during the month of July/2022 revenue collection was Rs.3,31,10,105.00. He further stated that regular raids are going on against illicit liquor. D.C. asked the Supdt. of Excise to convene a separate meeting with whole sale ware house dealers. The Supdt. of Excise further intimated that as discussed in the last DDC meeting the 3(three) seized container vehicles which were parking in the General Field 2(two) nos. of vehicle have already been shifted.
- 3) The Asstt. Commissioner of Taxes informed that during the month of July/2022 revenue collection was Rs.40,35,58,839.00 and the progressive collection upto July/2022 (2022-2023) was Rs. 90,43,95,700.00. The D.C. asked the Asstt. Commissioner to share any latest guideline to the HODs regarding deduction of tax etc. D.C. also asked the HODs to be very careful regarding GST/TAX.



- 4) Regarding construction/repairing works of Anti-Poaching Camps at Kaziranga under Untied Fund Scheme the D.C. asked the DFO, EAWLD, Bokakhat to submit inspection report immediately for early completion of the scheme.
- 5) The Deputy Commissioner asked the Executive Engineer Water Resource Department to meet the public complaint regarding alleged poor quality construction works of scheme B/dyke area from KRF Boundary to Dffoloo Pathar Scheme. D.C. also asked the E.E. to solve the problem of the Rongbong Scheme in consultation with NRL Authority and PHE Authority.
- 6) Meeting discussed on the progress of Paddy Procurement Scheme, PM-KISAN, Community Nursery Scheme, CMSGUY Scheme, RKVY Scheme, BGREI Scheme, NFSM Scheme, HMNEH Scheme, Machineries distributed under different schemes and also National Bee Keeping and Honey Mission scheme under Agriculture Sector.
- 7) Meeting discussed on the progress of RIDF (Phase-II), Construction Works, RKVY, BGRIE Scheme, SMAM Scheme, CMASGUY Scheme under Agriculture Engineering Department.

- 8) Meeting discussed on the progress of ongoing works under MGNREGA, PMAY-G, and scheme under ASRLM under P&RD.
- 9) Meeting discussed on the progress of Asom Mala Scheme under ASRIP. The Executive Engineer, PWD, Golaghat informed that the repairing works of PHG Path is going on. The D.C. asked the E.E. to take steps for repairing of Dhodar Ali. The D.C. also asked the PHE and APDCL Authority to cooperate with PWD Department for immediate submission of estimate regarding shifting of Electric Line and PHE water supply pipe line near PHG path.
- 10) Meeting discussed the progress of land acquisition matter of proposed construction of Railway Over Bridge at Kamarbondha and Golaghat and the progress of land acquisition of Dhodar Ali and PHG Path.
- 11) Meeting discussed on submission of valuation proposal towards construction of Dhodar Ali and in this regard the Deputy Commissioner asked the Executive Engineer, PWD (building) to take prompt action for submission of the proposals.
- 12) The meeting discussed the progress of the works under Dergaon Territorial Road Sub-Division and the Deputy Commissioner asked the representative concerned to take steps for repairing of the PHG Path under his administrative jurisdiction.
- 13) Meeting discussed the progress of PMGSY, RIDF, APART and SOPD (G) works under PWD, Sarupathar and Bokakhat Territorial Road Division also.



- 14) Regarding water logging problem in Numaligarh Tini Ali junction in front of Indian Oil Depot the D.C. asked the Asstt. Executive Engineer, PWD, NH Division, Golaghat to identify the reason of the problem and to find out the means of solution in consultation with SDO©, Bokakhat and NHIDCL authority. Regarding development of damaged portion of road at Numaligarh Tini Ali junction the representative from NHIDCL authority informed that action will be taken for development.
- 15) As reported by the Asstt. Executive Engineer, PWD, NH Division, Golaghat regarding alleged unauthorized construction of concrete mixture plant at near Numaligarh Truck Stand the Deputy Commissioner informed that action will be taken as per law.
- 16) Regarding construction of Gowdown /Warehouse for proper storage EVM's and VVPATs the Executive Engineer, PWD (Building) informed that the progress is 85% and the construction of One Stop Centre at Golaghat has been completed.
- 17) Regarding construction of RCC Two Storied Sales Tax Office Building the Executive Engineer, PWD (Bldg), Golaghat informed that notice has been served to contractor to complete the scheme.

- 18) Meeting discussed on the progress of Schemes taken under CIDF in Golaghat Town and the i/c of the project gave a briefing in this regard.
- 19) During discussion on Education Sector, the Inspector of Schools informed that the construction of ACR works, Major Repair, Boys Toilet and DYSF Girls Toilet has been completed. Meeting also discussed the MDM scheme.
- 20) Regarding Gr.III and Gr.IV interview to be held on 21st ,28th Aug/2022 and 11th Sept/2022 at various schools in Golaghat the I.S. of Schools requested the Deputy Commissioner, Golaghat to extend administrative help towards successful holding of the interview.
- 21) The representative from APDCL authority, Golaghat informed that Plan & Estimate is being prepared for shifting of electric line near PHG path which is to be constructed under Asom Mala. He also informed that electrification completed of all Anganwadi Centre and Primary School. He further informed that transformers under SOPD (2021-22) has already been delivered and installed.
- 22) While discussing on providing Nutrition Food to children under Social Welfare Department the Deputy Commissioner asked the DSWO to be very careful to avoid any unexpected incident recently occurred in Tinsukia District.
- 23) Meeting Discussed on the progress of various on going scheme implemented by Social Welfare Department (PMMVY / Poshan/SNP Etc. Scheme).



- 24) The Deputy Commissioner asked the I/C, Asstt. Director, F&CS and Food Safety Officer to be alert and to be more active to avoid any food poisonic incident occurred in the district as published in the News Papers.
- 25) Meeting discussed on the progress of PMEGP Scheme, PMFME Scheme, NEIDS Scheme, AIIP Scheme, National Bamboo Mission and MMTUBA scheme.
- 26) The CEO, Golaghat Zila Parished asked the District Officer, Soil Conservation, Golaghat to submit a list of Pond taken under the Soil Conservation Deptt. The D.C. stressed on the possibility of conversion of DRDA with Soil Conservation Scheme.
- 27) Meeting discussed the progress of RIDF, RKVY RAFFTAAR, APART, CMSGUY, PMMSY taken under Fishery Development Department.
- 28) During discussion of Health Sector the Joint Director, Health Services, Golaghat informed that the routine immunization to children is going on smoothly. He further appealed to all to maintain Covid Protocol. The D.C. asked the Health Department to organize more awareness camp regarding Japanese Encephalites and Malaria. D.C. also asked the Health Department to keep sharp watch in the flood affected areas to prevent any probable post flood disease.

- 29) The Executive Engineer, Irrigation, Golaghat-Sarupathar Division informed that proposal for 17 nos. of SMI Scheme under the division has already been submitted. The meeting discussed on the progress of Rengma FIS under AIBP and RIDF-XXV(NABARD) Scheme. The D.C. asked the Executive Engineer, Irrigation to convergent the Rengma FIS with DRDA
- 30) Meeting discussed the production of Eri cut cocoon and Muga Raw Silk and also discussed on SOPD-G Scheme, RKVY (RAFTAAR) and Muga Silk Outreach Mission scheme.
- 31) Meeting discussed the progress of RKVY Scheme, RIDF Scheme, NLM Scheme, SOPD-G, CMSGUY, Azadi-Se-Antyadoyatok Scheme, Mission Goat Production Scheme in Golaghat District. Meeting also discussed departmental activities of Veterinary Deptt. viz. Treatment of Live Stock, Vaccination, Castration, Artificial Insemination and Treatment & Vaccination Camp.
- 32)Progress of Weavers Mudra Loan Scheme, SAMARTH, SWA NIRBHAR NARI and Block Level Cluster under NHDP scheme were discussed in the meeting. Regarding disbursement of loan Supdt. of H&T will make proper coordination with LDM.



- 33) Meeting discussed on the progress on the JJM scheme under PHE Deptt. both Golaghat and Bokakhat and the matter of non electrification of schools and AWCs of the district.
- 34) Meeting discussed the progress of CIDF Scheme. The Dy. Director, T&CP gave briefing about the present status of CIDF Scheme.
- 35) Meeting discussed the progress of PMAY(U) scheme in Golaghat District implementing under T&CP.
- 36) Meeting discussed the progress of RIDF-XXIII, XXVI, RKVY-RAFTAAR, APART, PMMSY, CMSGUY Blue Revolution implementing under Fishery Department in Golaghat District.

In fine the Deputy Commissioner thanked the Hon'ble MLA, Dergaon LAC for his cooperation for making the DDC Meeting a success and requesting all officials to follow the suggestions / directions given in the meeting and gear up the development works in the district.

The meeting ended with vote of thanks from the Chair.
