

MINUTES OF THE DDC MEETING HELD ON 31-10-2022 IN THE CONFERENCE HALL OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF OCTOBER/2022 (.)

The meeting was Chaired by Dr. P. Uday Praveen, IAS, Deputy Commissioner, Golaghat in the presence of District Development Commissioner, Golaghat, CEO, Zila Parishad, Golaghat and the Heads of Development Department of Golaghat District.

The list of participants is given as Annexure – I.

Initiating the discussion the Deputy Commissioner sought full cooperation from the Heads of Development Department and exhorted them to work hard in implementing the schemes and programmes in a timely and smooth manner and emphasis should be given for the welfare of the people. He also asked them not to leave head quarters without prior permission from the authority. He further asked them to take DDC meeting seriously and to attend with full preparedness.

Department wise following points were discussed in the meeting.

FOOD CIVIL SUPPLIES & CONSUMAR AFFAIRS:

- 1) Discussed about the activation of E-pos machine and transaction of NFSA Commodities through E-pos Device by FPS dealers.
- 2) Milling capacity report of the rice mills.
- 3) Storage capacity report of PPC's.
- 4) District Level Vigilance & Monitoring Committee Meeting.
- 5) Dispose the pending cases within 15 days.

AGRICULTURE DEPARTMENT:

- 1) Meeting reviewed the status of PM-KISAN.
- 2) The officials from Agriculture Department informed that 12th installment 11365 nos. farmer were PFMS rejected and they were asked to open IPPB account at Post Office . As the progress of opening IPPB account is very slow, the D.C. instructed line department to take up the matter with LDM and regularize their bank account.
- 3) As the Kharif marketing season 2022-23(1st Crop) will start from 1st Dec/2022, the D.C. instructed to prepare the list of least 2000 probable farmers who will sell their paddy at MSP. As soon as the portal will open, certificate will be issued.
- 4) The Deputy Commissioner emphasized on collection of proposals from FPC for combined harvester at subsidized rate under CMSGUY.
- 5) Meeting discussed the progress of ongoing schemes.



AGRICULTURE ENGINEERING :

- 1) During discussion of RIDF Scheme the D.C. instructed to complete the sanction of DLSC approved beneficiary who have applied for STW and to complete the allotted target within March/2023.
- 2) Regarding SNAM scheme the D.C. instructed the department as early as possible.
- 3) The D.C. instructed the department to approve the CMSGUY beneficiaries in DLSC and to complete the allotted numbers for both mini rice mill and mini truck.

HEALTH & FAMILY WELFARE:

- 1) Meeting discussed the ANM rationalization. D.C. asked the department to submit a plan in this regard.
- 2) Regarding shifting of Maternity Wing to MCH building, D.C. instructed the department to submit requirements immediately.
- 3) Requirements of instruments for each health facility to be submitted to the D.C. by JE (Instrumentation).
- 4) D.C. informed that review will be done for every vertical programme.
- 5) The Addl CM&HO requested for construction of a public toilet at the office campus of the Joint Director, Health Services, Golaghat.

HANDLOOM & TEXTILES :

- 1) Meeting discussed about the scheme "SAMARTH" under Ministry of Textiles, Govt. of India.
- 2) Meeting reviewed the progress of the scheme "Weavers Mudra Loan" for the year 2022-23.
- 3) Meeting discussed about the allotment of land in respect of Handloom Park at Bongaligaon, Kaziranga.
- 4) Meeting discussed about the electricity connection and HTC, Rongagorah and HPC, Rongagorah.
- 5) Meeting discussed about the requirement of land for office of the Inspector, H&T WESU, Golaghat and Dergaon and office of the Instructor, H&T, HTC Dergaon.

FISHERIES DEPARTMENT :

- 1) During discussion of Fishery Sector the DFDO informed that BDMC formation in 15 nos. of beel fisheries under APART has been completed and the proposal will be submitted to DOF, Assam very soon. One village community tank will be constructed in each revenue villages under CMSGUY and RIAS scheme. Advertisement published in daily news papers inviting applications.
- 2) The DFDO informed that financial sanction received for 12 nos. of beel fisheries out of 14 nos. of from DOF, Assam under APART- 2022-23. Out of the at development works in 10 nos. of beel fisheries are in progress and financial sanctions yet to receive for rest 2 nos. of bills.
- 3) The DFDO informed that financial sanction received for establishment of fish seed multiplication centre at Bokakhat Fish Farm under APART.
- 4) The DFDO informed construction works are in progress in 3 nos. of small biofloc fish culture unit, one no. medium biofloc fish culture unit and one no. fish seed eco hatcharies.

- 5) The DFDO informed that under RKVY, construction of 4 nos. of Kuchia culture units are completed till date and rest 6 nos. beneficiaries will be replaced within a short time as they have not started work after repeated instruction. Under CMSGUY one unit of cage culture at Sankar Beel is in progress and proposal submitted to DOF, Assam for one more cage culture unit at Borsahalabeel at Bokakhat.

IRRIGATION DEPARTMENT :

- 1) The Executive Engineer, Irrigation, Golaghat- Sarupathar informed that Solar Powered MDTW scheme Pub-Sarupathar Area (2 pts.) under RIDF-XXV(NABARD) will be completed within Dec/2022.
- 2) The E.E. informed that one proposed scheme LTS from near Doyang at greater Gomari Area has been sanctioned under RIDF-XXVIII (NABARD) for the year 2022-23 and detailed project report has been submitted
- 3) The E.E. informed that the Gangway slab of Rengma FIS has been recommended after observing the defects in it. He also reported that the work orders of the Guide Bund and Afflux Bund of the Rengma FIS have been cancelled and revised estimate has been submitted to the higher authority. The Deputy Commissioner instructed the EE to complete the scheme by 2023. The DC also stated that he will visit the scheme by December/2022.
- 4) The meeting discussed about the progress of ongoing project under BokakhatKhumtai Division (Irrigation). The Executive informed that the scheme Solar Powered MDIWS in MoutChapori under Bokakhat LAC (RIDF -XXVI) was delayed by 1(one) year due to cancellation of tender thrice due to legal issues. Now the work is in progress and expected to be completed by Dec/2022. There is no issue at present at other ongoing schemes under RIDF-XVII and SOPD schemes.

TOWN & COUNTRY PLANNING:

- 1) During discussion of the Urban Development Sector the Deputy Commissioner informed that ongoing CIDF Project at Golaghat reviewed recently and inspect the schemes in a phase manner and asked the Deputy Director, T&CP to intimate the implementing agency i.e. DoHUA to keep ready the Plan & Estimates of the CIDF Project and he further informed that 2 (Two) nos. of scheme will inspect on 8th Nov/2022 and the remaining scheme will be inspected after 8th Nov/2022.

P.W.D. BUILDING :

- 1) Meeting discussed about the progress of various works under this division. The Deputy Commissioner asked the E.E. to complete the works within the targeted period.
- 2) The E.E., PWD (Bldg), Golaghat requested for early shifting of the Golaghat - Sarupathar (Irrigation) Division office to the allotted old PWD ® office building as the integrated Deputy Commissioner Office Building construction work will be started soon.
- 3) The E.E., PWD (Bldg) stated that the remaining 77 Bighas land out of 120 Bighas land allotted for Birangana Sati Sadhani State Cultural University has yet to be handed over. The E.E. PWD, Bldg. requested for early handed over the remaining land.

SOIL CONSERVATION :

- 1) The D.O. Soil Conservation Division, Golaghat informed that the "Anti-erosion cum water conservation measures at Amguri (Doyang River)" under RIDF-XXV-2019-20 has been



going on with 75% progress and will be completed within November/2022. He also informed that the district is likely to receive one project under RIDF-XXVIII -2022-23.

- 2) The "Development of Marshy Land with creation of pond at Kathkatia, Golaghat -2021-22 will be started soon. The Administrative Approval of the project has been received at the end of financial year and hence it was not possible to start in the last working season after doing all the formalities i.e. tendering work order etc.
- 3) A scheme "Wetland Development with creation of pond at Dhansiripar Village", South Development Block has been submitted at Dispur for Administrative Approval.
- 4) A flagship programme "Golaghat (Doigrung) WDC-PMKSY 2.0 is going on for discussion of which with all the members of WCDC under the Chairmanship of the DC, the DO Soil Conservation requested the DC to provide a date. The D.C. asked the DO to send a letter to him in this regard. The tentative date has been given by him is 15th Nov/2022.

EXCISE DEPARTMENT:

- 1) The Superintendent, Excise, Golaghat informed that Rs.2.99 crores have been collected online in the month of October/22 till 31-10-22 and 52.5% of target has been achieved.
- 2) A meeting with the licensees would be held between 2nd to 3rd week of November/22 where retailers would be asked to lift requirements from warehouses within the district so that rise in consumption is reflected in the revenue figures.
- 3) The Deputy Commissioner asked Excise Department to intensify enforcement activities.

EMPLOYMENT EXCHANGE:

- 1) The Asstt. Employment Officer, Golaghat gave a briefing about the progress of on online registration.

SERICULTURE DEPARTMENT :

- 1) The Deputy Commissioner instructed the ADS to give much more emphasis on the field level activities and set a team to find out the sericulture pockets of different areas like eri, muga and mulberry and to identify the interested families for awareness, assistance and helping them to double their income through sericulture activities within a span of one year.

WATER RESOURCE :

- 1) The Executive Engineer, Water Resource informed that the ongoing schemes in Golaghat District will be resumed from November/22 as flood season is now over.
- 2) The E.E. informed that all the ongoing works will be completed before 31st March/2022.
- 3) The E.E. informed that Kakodonga SOPD-FDR of 2019-20 will be foreclosed due to land issues.

LABOUR DEPARTMENT :

- 1) While discussing on Labour Department the Deputy Commissioner instructed line department to check whether the contract labour licenses, interstate migrants licences were obtained or not during issuance of no objection certificate to all the bricks field so that govt. revenue/taxes can be obtained. Besides it is also requested to provide the list of all bricks field with exact location to labour department.
- 2) The ALC requested the Social Welfare Department to set up Anganwadi Centre at the Brick Field to cater education to the children of the worker families.

VETERINARY DEPARTMENT :

- 1) Meeting discussed about F.M.D. Vaccination in Cattle.
- 2) Discussed about KCC Loan.

URBAN WATER SUPPLIES :

- 1) During discussion on Urban Water Supply Sector the Deputy Commissioner asked the i/c UWS, Golaghat to hand the Urban Water Supply schemes to concerned Urban Local Bodies.

PANCHAYAT & RURAL DEVELOPMENT:

- 1) The DPM ASRLM Golaghat gave presentation on physical progress of ASRLM in Golaghat. The Deputy Commissioner asked to emphasize on credit linkage to all SHGs.
- 2) The DPM apprised the house that many SHG members are defaulters and their CIBIL score is low. The Deputy Commissioner instructed the LDM to issue instruction to banks stating that to check president, Secretary and Treasurer CIBIL score to disburse loan to the SHGs. The D.C. instructed the DPM to change the committees of those SHGs accordingly.
- 3) Discussed about the progress of PMAGY.
- 4) Discussed about the progress of MGNREGA.

PUBLIC HEALTH ENGINEERING:

- 1) Discussed about the progress of Pipe Water Scheme.
- 2) Reviewed about the physical and financial progress of the scheme under SOPD(G) under Golaghat PHE Division.
- 3) Reviewed about the physical progress of the ongoing scheme.
- 4) Discussed about the progress of the scheme under NRDWP.
- 5) Reviewed about the physical progress of the scheme under the programme of JJ Mission.

SOCIAL WELFARE :

- 1) Discussed about the progress of Model AWCs and DSWO was suggested to complete the construction immediately.
- 2) On a query from the D.C. the DSWO informed that 187 nos. of SAM children and 7 nos. of critically malnourished children are present in the district.
- 3) Regarding distribution of UDID Card the DSWO informed that due to shortage of doctors, identification of disabled persons has been slowed down and in turn reduces UDID card distribution.
- 4) Regarding PMMVY, DSWO informed that 13514 nos. of pregnant and lactating mother's date have been uploaded on the portal.

FOREST DEPARTMENT (T):

- 1) Discussed regarding vehicles found over loaded carrying illegal logs and fine imposed.
- 2) Discussed regarding checking of vehicles carrying forest products and realization of Tax/Fine/Penalty etc. from defaulters.



- 3) DFO(T) to furnish a detailed list of brick fields of the district. DFO(T) also to furnish the list of organization who is involved against diversion of 70.68 hac. Plantation to be carried out.
- 4) Meeting discussed on the progress of Untied Fund Scheme-2020-21 namely "Repairing of Anti-Poaching Camps at Kaziranga National Park and Tiger Reserve".
- 5) Regarding release of 2nd/Final Installment from the district administration and in the interest of quick implementation of the scheme and considering the work load of the Circle Officer, Bokakhat the verification of the schemes 10% schemes will be verified by Circle Officer, Bokakhat and the rest will be done by concerned Range Officer and PWD (Building) Officials. The DFO Wild, Bokakhat will take necessary steps in this regard.

P.W.D. (Golaghat and Khumtai Territorial Road Division):

- 1) Meeting discussed the progress of PMGSY, RIDG, APART and SOPD (G)works.
- 2) Meeting Discussed on Asom Mala Scheme.

P.W.D. (Sarupathar Territorial Road Division):

- 1) During Discussion of this sector the D.C. asked the Executive Engineer to submit a report of spot identification of accident prone road locations and solution to the problem .
- 2) Discussed regarding slow progress of up gradation of Warehouse under APART.
- 3) Discussed about the progress of Tengabari to Kachamari Road.
- 4) Discussed about the progress of SOPD-G scheme.

EDUCATION :

- 1) Discussed thoroughly on Mission Bhumiputra Scheme.
- 2) Meeting discussed on upcoming Gunotsov.
- 3) Regarding opening of students zero balanced accounts the D.C. asked the LDM to take positive steps.
- 4) Students Aadhar

APDCL LIMITED :

- 1) The Deputy Commissioner asked Power Department to co-ordinate with PHE Department in releasing electricity connection to all pending JJM works.
- 2) D.C. Golaghat also ensured that he will give nominee" Assam Distribution System enhancement & loss reduction Project" to be implemented by APDCL under EAP scheme.

INDUSTRIES AND COMMERCE :

- 1) During discussion of this sector the Deputy Commissioner asked the General Manager, DI & CC, Golaghatto take immediate steps for arrangement of land for setting up a Industrial State/Industrial Park at Morangi.


TRANSPORT DEPARTMENT :

- 2) D.C. will visit the milk processing unit at Bokakhat under this sector.

The meeting ended with a vote thanks from the Chair.


