

MINUTES OF THE DDC MEETING HELD ON 11-03-2022 AT 10-30 AM IN THE CONFERENCE HALL, OFFICE OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF MARCH/2022 (.)

The meeting was held in presence of Heads of various Development Departments of the district and Chaired by Shri M.N. Baruah, ACS, Deputy Commissioner, Golaghat.

The list of participants are given in Annexure - I.

At the very outset the Deputy Commissioner, Golaghat welcomed the members present in the meeting and asked the heads of Development Department to ensure for completion of incomplete and on going schemes on time.

After that the meeting discussed elaborately and emphasized on the following aspect.

- 1) The i/c District Social Welfare Officer, Golaghat apprised that construction of 11 nos. of Model Anganwadi Centers in each LA Constituency in Golaghat District are going on and 7 nos. of MAWC of Khumtai LAC and 5 nos. of MAWC of Golaghat LAC have already been completed. Meeting also discussed on SAM and also the progress of UDID. D.C. asked the Heads of Development to share any information to the Health and Social Welfare Department regarding SAM. She also informed that though the progress of UDID registration is very slow, efforts are being taken to increase the progress with the help of Health Department. D.C. asked the J.D. Health and DSWO to take steps for achieving the progress UDID by increasing the man power.
- 2) Meeting discussed on the occurrence of Diarrhoea at Bogidhola Tea Garden and in this regard D.C. asked the J.D. Health to take immediate steps for prevention and control of the disease. Regarding T.B. disease J.D. Health requested the Heads of Development Department to share any information with Health Department. Meeting also discussed on Atal Amrit Abhiyan Scheme.
- 3) Meeting discussed on the progress on the JJM scheme of the District. D.D. stated that a separate meeting will be held within 20th March/2022 with the PHE Deptt., School Deptt., APDCL, Social Welfare Deptt. regarding non electrification of schools and AWCs of the district.

- 4) Regarding outstanding dues against electricity bills the D.C. asked the heads of development department to take steps for clearance of the dues.
- 5) Regarding collection of Revenue / Tax , concerned District Heads are directed to work hard for achieving the target. District Administration will make frequent review with Transport Department/Tax Department/Excise Department/Forest/ Revenue Department etc.
- 6) Meeting discussed on the progress of PMKSY scheme under Soil Conservation Department.
- 7) Meeting discussed on PM-KISHAN, PMKSY, RKVY, Horticulture Mission and the paddy procurement status under Agriculture Department.
- 8) Meeting discussed on the progress of CMSGUY and SMAM scheme under Agriculture Engineering Sector.
- 9) While discussing on Irrigation Sector the D.C. asked the Executive Engineer, Irrigation to keep close touch with Agriculture Deptt. and Soil Conservation Department.
- 10) Regarding proper disbursement of PMEGP loan Industry Department will make proper and frequent communication with bank authorities.
- 11) Discussed on the progress of RKVY Scheme, RIDF Scheme, Rastriya Gokul Mission Scheme, National Livestock Mission and National Animal Disease Control Programme and Mission Goat Production scheme of Veterinary Department.
- 12) The DDM, NABARD requested the heads of development department to submit utilization certificate regarding NABARD related scheme. D.C. also asked the HODs to share the progress of NABARD related scheme with DDM, NABARD.
- 13) Regarding deposit of renewal fees of NIRMAN SHRAMIK under Assam Building and Construction Workers Welfare Board Accounts the Asstt. Labour Commissioner will communicate with LDM and he will extend his help and cooperation.
- 14) Meeting discussed on the scheme of Swa Nirvhar Nari scheme, Working Capital Assistance to PWCS scheme, Weavers Mudra Loan Scheme and SAMARTH Scheme under Handloom Scheme.
- 15) Meeting discussed thoroughly on the aspects of Sericulture related scheme. Meeting also discussed on Muga rearing and reeling project conducted with the Sericulture deptt. and NRL. Regarding livelihood of the forest communities, the D.C. informed that he will visit the villages in pocket areas where Sericulture activities are carried out with Forest Deptt., H&T Deptt. and Sericulture Deptt. within a short time.
- 16) Discussing on Water Resource Department the Deputy Commissioner asked the Executive Engineer, WR Deptt. to complete the all flood protection works by 31st March or latest by April/2022.
- 17) DPO, DDMA requested the PWD (Building) to expedite the tender process and construction of DEOC building under DDMA Golaghat. Fishery Deptt. to submit list of


beneficiaries of flood 2021 for payment under SDRF. All HODs concerned are requested to nominate one Nodal Officer for Disaster Management activities and to submit SDRF proposal of recent hailstorm damages as per SDRF template at the earliest for counter signature of the Deputy Commissioner.

- 18) Discussing on Education Sector the Deputy Commissioner asked the DEEO to start repair works in 117 nos. of school which were partially damaged due to 2021 flood damages and approved at SEC meeting.
- 19) D.C. asked the Asstt. Executive Engineer, PWD (Bldg), Golaghat to complete the Tea Garden Model School immediately. On a query from the D.C. the AEE informed the assessment proposal of valuation of widening of Dhodar Ali under Assam Mala is going on and will submit very soon.
- 20) While discussing on PWD (Road) sector the D.C. asked the E.E. PWD (Roads) Golaghat to take steps for repairing the PHG Path. The Executive Engineer requested the Circle Officer, Golaghat, Dergaon, Khumtai and Morangi Revenue Circle to submit the list of village alongwith map near PHG Path as early as possible. The E.E. also requested the PHE Deptt. to submit an estimate for shifting of water line within the 8 mtrs. of PHG Path. The EE also requested the APDCL, Golaghat to submit an estimate for shifting of Electric Pool near PHG Path as communicated earlier.
- 21) Discussing on P&RD Sector, the D.C. asked the PD, DRDA to find out the possibility for increasing of 100 days job to job card holder under MGNREGA and the possibility of cluster basis PMAY house to land less families.
- 22) While discussing on Fishery Sector the D. C. asked the DFDO to complete the Beel Fishery Development scheme immediately. D.C. also asked the Executive Engineer, PWD (Roads), Golaghat to accord T.S. of the estimates of Fishery Department under APART Scheme.
- 23) The Asstt. Director apprised the meeting about the present status and progress of CIDF scheme under Golaghat Municipal Board. The D.C. asked the District Sports Officer to extend help and cooperation toward smooth implementation of sports related scheme under CIDF.

The meeting ended with vote of thanks from the Chair.
