
The list of participants are given in Annexure – I.

At the very outset the Deputy Commissioner, Golaghat on behalf of the District Administration offered warm welcome the Hon'ble Minister and said that the District Administration was really very thankful for his kind presence in the meeting and valuable time shared with the District Administration and Heads of various Development Departments. The D.C. also stated that the meeting is being convened to discuss and review on developmental schemes and their progress. The Deputy Commissioner referred the C.M.'s review meeting to be held on 12th and 13th June/2022 and accordingly concerned heads of development departments were asked to submit progress report by 10th June/2022. The Deputy Commissioner stated that flood season has already been started and he asked the Heads Development Department to work in a war footed manner and to work hard for achieving the target.



Officials to implement the schemes and programmes in such a manner that benefits are transferred to the people in a timely and smooth manner and emphasis should be given for the welfare of the people. He hoped for full cooperation from all departments and exhorted them to work hard for better development of the district. He also requested the members to maintain team spirit for achievement of better result.

Thereafter, the meeting discussed sector wise developmental schemes in detail and reviewed the action taken of the last minutes of the DDC as follows:-

- 1) Meeting discussed on PM-KISAN. DAO will give top priority on the progress of PM-KISAN. DAO will ensure that the genuine kissan will not be deprived.
- DAO will take steps to activate the accounts of PM-KISAN beneficiaries under stopped payment categories within 10(ten) days.



- 3) DAO will take steps to collect new form from the MP-KISAN beneficiaries who have not yet applied till date.
- 4) Meeting discussed on the progress of Water Resource Sector. Regarding Rongbong Scheme PHE deptt. will tie up with Water Resource Department and to convene a joint meeting to solve the problem.
- 5) Water Resource Department will keep strict vigil on the vulnerable areas during flood season.
- 6) Meeting discussed on the progress of Moriaholla scheme, Reri Alengmari Scheme, Opeswarighat Scheme, Singphura Ghat Scheme and also discussed the progress of FDR scheme under Water Resource Department.
- 7) Meeting discussed the matter of installation of 440 electric line over the building of Anandapur LP School Building at Bokakhat Town and the APDCL authority informed that the matter has been solved.
- 8) Meeting discussion the matter of guarding the electric line near Kaziranga and APDCL authority will take necessary steps.
- 9) Meeting discussed on the progress of proposed International Agor Trade Centre at Dabidubi. DFO Golaghat and GM, DI & CC will keep proper coordination regarding plantation at Dabidubi. DFO informed that plantation will be completed within Nov/2022.
- 10) Industry Department will take necessary steps and will make necessary coordination with concerned authority for speedy progress of the International Agor Trade Centre at Dabidubi.
- 11) Meeting discussed on the progress of PMEGP Scheme, PMFME Scheme, NEIDS Scheme, AIIP Scheme, National Bamboo Mission and MMTUBA scheme.
- 12) During discussion on PWD Sector both Golaghat/ Bokakhat/ Sarupathar Sector meeting discussed the progress of PMGSY/SOPD/Regular Scheme.
- 13) The Executive Engineer, PWD, Sarupathar will take necessary steps for repairing of damaged portion near Jamuguri Bridge.
- 14) Meeting discussed the progress of Survey works of proposed flyover above designated corridor of KNP.
- 15) Meeting discussed on the progress of Asom Mala Scheme.
- 16) Meeting discussed on repairing of PHG Path. The Executive Engineer, PWD informed that proposal has already been submitted and steps will be taken for repairing the road.
- 17) Meeting discussed on the matter of development of damaged portion of road and water logging problem in Numaligarh Tini Ali junction in front of Indian Oil Depot. and



- accordingly Executive Engineer, NH will take necessary steps. Executive Engineer, NH will also make necessary coordination with NHIDCL Authority in this regard.
- 18) Meeting discussed the progress of "Axadi Se Antyadaya Tak" scheme.
- 19) Meeting discussed on Flood Preparedness Programme.
- 20) Meeting discussed on the progress of Online Registration under Employment Department.

- 29) During discussion on Cooperative Sector the meeting discussed on Multipurpose Cooperative Society.
- 30) The ARCS will submit a status report on Cooperative Society in Moinapara area.
- 31) During discussion of Health Sector the Joint Director Health informed about the shortage of Doctor. He also informed about the sufficient stock of medicine.
- 32) Meeting discussed on appointment of a Gynecologists at Sarupathar Civil Hospital and a doctor at Dusutimukh Hospital.
- 33) The Joint. Director will ensure the cleanliness of Kushal Konwar Civil Hospital.
- 34) Meeting discussed on outbreak of African Swine Flu and its prevention in the district.
- 35) Veterinary Deptt. will take special attention on African Swine Flu.
- 36) Divisional Officer, Soil Conservation will inform about the Activities of Soil Conservation

 Department in the District to the concerned MLAs. Regarding disbursement of KCC


 LAD will take necessary positive steps.

- 39) Meeting discussed on using insecticides/pesticides/BT and other sprays by the small tea growers as well as tea estates and its impact on production of Muga Silkworm.
- 40) Meeting discussed on issuing of notice to the small tea growers as well as tea estates against the use of insecticides/presticides/BT and other sprays in the neighbouring som plantation areas of Farm/Centres/VGRs/Private Farmers during the month of April to November.
- 41) Discussed on the progress of various on going scheme implemented by Social Welfare Department (PMMVY/Poshan/SNP Etc.Scheme).
- 42) Meeting discussed on collection of Revenue /Tax. Concerned District Heads are directed to work hard for achieving the target.
- 43) Supdt. of Excise will take action against illicit liquor and will identify the vulnerable areas and will organize village level meeting to avoid any untoward incident occurred like in the few years ago.
- 44) Meeting discussed on the progress of various ongoing schemes implemented by the Handloom & Textiles, Golaghat.
- 45) Progress of Weavers Mudra Loan Scheme, SAMARTH, SWA NIRBHAR NARI and Block Level Cluster under NHDP scheme were discussed in the meeting. Regarding disbursement of loan Supdt. of H&T will make proper coordination with LDM.
- 46) District Sports Officer to extend help and cooperation toward smooth implementation of sports related scheme under CIDF.
- 47) Meeting discussed on the progress of CIDF Scheme. Deputy Director, T&CP, Golaghat will take steps for speed up the scheme.
- 48) The next DDC Meeting for the month of July/2022 will be held on 5th July/2022.
