

MINUTES OF THE DDC MEETING HELD ON 09-05-2022 AT 10-30 AM IN THE CONFERENCE HALL, OFFICE OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF MAY/2022 (.)

The meeting was held in presence of Heads of various Development Departments of the district and Chaired by Shri M.N. Baruah, ACS, Deputy Commissioner, Golaghat.

At the very outset the Deputy Commissioner, Golaghat welcomed the members present in the meeting and asked the Heads of Development Department to follow the govt. direction regarding 1(one) year completion of the present government and also asked them to extend full cooperation towards successful holding of Gunotsav programme to be hold w.e.f. 23rd to 25th May/2022. The D.C. also asked the concerned SDO (Civil), Circle Officers and B.D.O.s who are the President of Construction Committee to instruct the Member Secretary concerned to submit pending U.C.s/ documents under MP-LAD, MLA-LAD and Untied Fund Schemes as the govt. is pressing hard for submission of U.C.s/Etc. D.C. also gave a briefing about the new scheme "Amrit Sarovor" in the meeting. All heads of development department were also directed to submit Flood Preparedness Plan immediately who have yet to submit.

- 7) Meeting discussed on the progress of Online Registration under Employment Department.

- 12) Meeting discussed thoroughly on Gunotsav Programme to be held on 23rd, 24th and 25th May/2022 in Golaghat District and heads of deptts. were asked to extend their help and cooperation towards successful holding of the programme. APDCL will take necessary steps regarding uninterrupted power supply during Gunotsav Programme.
- 13) A training programme will be held on 18th , 19th and 20th May/2022 on Gunotsab Programme.
- 14) APDCL authority will look into the matter of installation of 440 electric line over the building of Anandapur LP School Building at Bokakhat Town.
- 15) SDO (Civil) Bokakhat/Sarupathar will review the progress of PHE Schemes under their jurisdiction.
- 16) Meeting discussed on collection of Revenue /Tax. Concerned District Heads are directed to work hard for achieving the target from the beginning of the Revenue year.
- 17) Supdt. of Excise will take action against illicit liquor and will identify the vulnerable areas and will organize village level meeting.
- 18) Meeting discussed on the progress of Irrigation Sector. For successful implementation of the irrigation scheme Soil Conservation Deptt./Agriculture Deptt./DRDADeptt./Irrigation Department will make proper coordination between them.

- 25) Regarding Development of Marshy Land with creation of pond at Kathkotia Village, Golaghat taken under Soil Conservation Department the District Fishery Development Officer, Golaghat will visit the project and submit a report in the next DDC meeting.
- 26) Meeting discussed on the progress and submission of U/C etc. of MP-LAD/MLA-LAD/Untied Fund scheme. The D.C. asked the concerned SDO(C)/Circle Officers/BDOs who are the president of the construction committee to instruct the member secretary concerned to submit U.Cs/ documents and to complete the schemes on time.
