

MINUTES OF THE DDC MEETING HELD ON 05-07-2022 AT 10-30 AM IN THE CONFERENCE HALL, OFFICE OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF JULY/2022 (.)

The meeting was held in presence of Heads of various Development Departments of the district and Chaired by Smti. Orpah Baglary, ACS, District Development Commissioner, Golaghat.

The list of participants are given in Annexure – I.

At the very outset the District Development Commissioner, Golaghat welcome the members present in the meeting. The meeting observed one minute silent in the memory of deceased M.N. Dutta, Supt. Engineer, Golaght Road Circle and expressed deep condolence to his family.

Initiating the discussion the District Development Commissioner referred the C.M.'s review meeting held on 12th and 13th June/2022 at Tezpur and accordingly concerned heads of development departments were asked to take necessary positive action on the minutes of discussion. The DDC also asked the Executive Engineer, Water Resource Deptt. to keep strict vigil on the vulnerable point to avert any flood situation prevailing like in other district of Assam. She also asked the Heads of Development Department to submit a writ up on the Bir Lachit Borphukan as desired by the Hon'ble Chief Minister of Assam. The DDC stressed on the proper coordination amongst the Development Department for successful implementation of the scheme and thereby achieving the target. The DDC also asked the concerned Heads of Development Department to submit damaged report of any calamities to the DDMA as early as possible.

Thereafter, the meeting discussed sector wise developmental schemes in detail and reviewed the action taken of the last minutes of the DDC as follows:-

- Meeting discussed on prevailing flood situation in the district and all heads of development department were asked to be alert.
- 2) Water Resource Department will keep sharp watch on the vulnerable point of the district.
- 3) DDS, F&CS will take necessary steps for handing over the lock & key of the Godown where the geo bags under Water Resource Department are stored and the Executive Engineer will also communicate with SDO ©, Bokakhat in this regard.
- Meeting discussed on the progress of construction of Guest House at Kohora of Water Resource Department under SOPD-G for the year 2020-21.



- Meeting discussed thoroughly on completed and on going scheme of Water Resource Department.
- 6) Meeting discussed on the progress of Rongbong Scheme, Moriaholla scheme, Reri Alengmari Scheme, Opeswarighat Scheme, Singphura Ghat Scheme and also discussed the progress of FDR scheme under Water Resource Department.
- 7) Meeting discussed thoroughly on PM-KISAN. Stop Payment, Stop Payment Revocation, Eligible Farmer, Ineligible Farmer, New Enrolment Form, Aadhaar Seeding Data, New Form Uploaded in portal under PM-KISAN were also discussed thoroughly.
- 8) DAO will give top priority on the progress of PM-KISAN. DAO will ensure that the genuine kissan will not be deprived.
- Meeting discussed on progress of Paddy Procurement ,CMSGUY and PM-KSY scheme.
- 10) Meeting discussed on the progress of RIDF (Phase-II), Construction Works, RKVY, BGRIE Scheme, SMAM Scheme, CMASGUY Scheme under Agriculture Engineering Department.
- 11) Meeting discussed on the progress of Asom Mala Scheme under ASRIP. The EE, PWD, Golaghat informed that the Works under Asom Mala for the year 2021922 LOA received but FWO not yet received.
- 12) Meeting discussed on repairing of PHG Path. The Executive Engineer, PWD, Golaghat informed that the repairing works of PHG Path delayed due to heavy rain fall.
- 13) The E.E. PWD (R), Golaghat informed that conversion of SPT Bridge into RCC Bridges out of 4 nos. of bridges 3 (three) nos. have already been completed and the progress of the other bridge work is 99%.
- 14) Meeting discussed on SDRF works. The E.E., PWD, Golaghat informed that all works under SDRF for the year 2017-18 have already been completed. He also informed that the out of 6 nos. of SDRF works for the year 2020-21 5 nos. works have been completed and the SDRF works for the year 2021-22 only AA received.
- 15) Meeting discussed the progress of the scheme under CIDF and PMAGY for the year 2019-20 and the EE, PWD, Golaght informed that all works completed in all respect.
- 16) The meeting discussed the progress of the works under Dergaon Territorial Road Sub-Division.
- 17) Meeting discussed the progress of PMGSY, RIDF, APART and SOPD (G) works under PWD, Sarupathar and Bokakhat Territorial Road Division.



- 18) Meeting discussed about the proposed Railway Flyover at Kamarbondha and Golaghat.
- 19) Meeting discussed on the matter of development of damaged portion of road and water logging problem in Numaligarh Tini Ali junction in front of Indian Oil Depot.

 The DDC asked the Executive Engineer to solve the problem coordinating with NHIDCL Authority and the E.E. will also communicate with SDO©, Bokakhat in this regard.
- 20) Meeting discussed the present status of on going scheme of Model High School Tea Garden areas under PW (B&NH) Deptt., Golaghat.
- 21) While discussion on the progress of construction of Border Out Post of Assam Nagaland Border the DDC asked the PWD authority to complete the works immediately.
- 22) Regarding construction of RCC Two Storied Sales Tax Office Building the representative from PWD (Bldg) deptt. informed that notice has been served to contractor to complete the scheme and the construction of Gowdown /Warehouse for proper storage EVM's and VVPATs the progress is 83% and the construction of One Stop Centre at Golaghat has been completed.
- 23)Meeting discussion the matter of guarding the electric line near Kaziranga and APDCL authority, Golaghat informed that Plan & Estimate for the same is being prepared.
- 24)Meeting discussed the progress of Electrification of Agnagwadi Centre and Primary School. The representative from APDCL, Golaghat informed that electrification completed of all Anganwadi Centre and Primary School. He also informed that transformers under SOPD (2021-22) has already been delivered and installed.
- 25) Meeting discussed on the progress of proposed International Agor Trade Centre at Dabidubi. Industry Department will take necessary steps and will make necessary coordination with concerned authority for speedy progress of the Trade Centre. DFO Golaghat and GM, DI & CC will keep proper coordination regarding plantation at Dabidubi.
- 26) Meeting discussed on the progress of PMEGP Scheme, PMFME Scheme, NEIDS Scheme, AIIP Scheme, National Bamboo Mission and MMTUBA scheme.
- 27) During discussion of Health Sector the representative from Health Sector informed that the routine immunization to children is going on smoothly. He also informed that progressive health check up camp / Awareness Camp held 158 nos. He further



appealed to all to maintain Covid Protocol. The D.C. asked the Health Department to organize more awareness camp regarding Japanese Encephalites and Malaria. She also asked the Health Department to keep sharp watch in the flood affected areas to prevent any probable post flood disease. Regarding appointment of doctor in Model Hospital, Sarupthar the representative from Health Department informed that due to shortage of doctor the appoint could not be done. The Joint. Director, Health will ensure the cleanliness of Kushal Konwar Civil Hospital.

- 28) The Asstt. Commissioner of Taxes informed that total collection upto June/2022 was Rs. 5008.37 Lakh against the total target for the year 2022-23 Rs.19624.00 Lakh.
- 29) The District Transport Officer, Golaghat reported that during the month of June/ 2022 Revenue collection was Rs. 2,64,48,638.00.
- 30) The Superintendent of Excise, Golaghat informed that during the month of June/
 2022 total revenue collection was Rs. 2,67,69,655/- The asked the Supt. of Excise to take steps for immediate shifting of sized truck from General Field to a suitable alternative place as the beautification/renovation/developmental works are going on there.
- 31) The Executive Engineer, Irrigation, Golaghat-Sarupathar Division informed that proposal for 17 nos. of SMI Scheme under the division has already been submitted. The meeting discussed on the progress of Rengma FIS under AIBP and RIDF-XXV(NABARD) Scheme.
- 32) Meeting discussed the progress of ongoing scheme under RIDF, SOPD and Natural Resource Management (NRM) works under Soil Conservation Department.
- 33) During discussion of Sericulture Sector the Asstt. Director, Sericulture informed that during the month of June/2022 the production of Eri cut cocoon and Muga Raw Silk was 5.325 MT & 0.022 MT respectively. Meeting also discussed on SOPD-G Scheme, RKVY (RAFTAAR) and Muga Silk Outreach Mission scheme.
- 34)On a query from DDC the D.V.O., Golaghat informed that no outbreak of African Swine Flu has been received in this district. Meeting discussed on RKVY Scheme, RIDF Scheme, NLM Scheme, SOPD-G, CMSGUY, Azadi-Se-Antyadoyatok Scheme, Mission Goat Production Scheme in Golaghat District. Meeting also discussed departmental activities of Veterinary Deptt.



- 35) Discussed on the progress of various on going scheme implemented by Social Welfare Department (PMMVY / Poshan/SNP Etc. Scheme).
- 36) Progress of Weavers Mudra Loan Scheme, SAMARTH, SWA NIRBHAR NARI and Block Level Cluster under NHDP scheme were discussed in the meeting. Regarding disbursement of loan Supdt. of H&T will make proper coordination with LDM.
- 37) Meeting discussed the progress of MGNREGA-2022-23, PMAY- G Registration and Geo Tagging and SHG received RF under NRLM fund under District Rural Development Agency.
- 38) While discussing the Education Sector meeting discussed on the progress of Development of Playground of the schools, Progress of Civil Works and Tea Garden Schools.
- 39) Meeting discussed on the progress on the JJM scheme under PHE Deptt. both Golaghat and Bokakhat and the matter of non electrification of schools and AWCs of the district. APDCL authority, Golaghat will provide a list of electrified school and AWCs.
- 40) Meeting discussed the progress of CIDF Scheme. The Dy. Director, T&CP gave briefing about the present status of CIDF Scheme.
- 41) Meeting discussed the progress of PMAY(U) scheme in Golaghat District implementing under T&CP.
- 42) Meeting discussed the progress of RIDF-XXIII, XXVI, RKVY-RAFTAAR, APART, PMMSY, CMSGUY Blue Revolution implementing under Fishery Department in Golaghat District.
- 43) While discussing on Sports Sector the District Sports Officer, Golaghat gave briefing about the progress of playfield development work under Assam Youth Development Mission Society (AYDMS) of MMS-CMSGUY.
- 44) D.D.C. asked the Officials representing from Assam Gas Company Ltd. to attend the DDC meeting regularly. She also asked the Officials to inform the development activities taken in Golaghat from their part
