

MINUTES OF THE DDC MEETING HELD ON 07-02-2022 AT 10-30 AM IN THE OFFICE CONFERENCE HALL OF THE DEPUTY COMMISSIONER, GOLAGHAT FOR THE MONTH OF FEBRUARY/2022 (.)

---

The meeting was held under the Chairmanship of Shri M.N. Baruah, ACS, Deputy Commissioner, Golaghat.

**The list of participants are given in Annexure – I**

Initiating the discussion the Deputy Commissioner directed the Heads of Development Department to devote to their works in full swing and to complete the ongoing as well as new schemes as the deptts. are having very short working season to achieve the target. The concerned Heads of Development were were also asked to submit action plan on Axom Adarxo Gram Yojana as early as possible for onward submission to the Govt. The D.C. also asked the Circle Officers and the HODs particularly Agriculture, Veterinary Deptt. to submit damaged report regarding hail storm occurred on 5<sup>th</sup> February/2022 in various places of the district.

Thereafter, the meeting discussed sector wise developmental schemes in detail and reviewed the action taken of the last minutes of the DDC as follows :-

**AGRICULTURE :** The District Agriculture Officer, Golaghat informed that upto the month of January/2022 total crop area covered : Sugarcane 1035 hac., Kharif Maize 200 hac., HYV Paddy 700 hac., Hybrid Paddy 600 hac., Hybrid Maize 650 hac and Potato 10 hac. and the fertilizer consumption during the month of January/2022 was : Uria 469 MT, SSP 134 MT, MOP 130 MT and DAP 188 MT. Regarding CMSGUY scheme the Deputy Commissioner asked the DAO to submit Revenue Circle wise list to him at an early date. The DAO also informed that under PM-Kisan total 607 nos. of form uploaded in portal and total stop payment as on date 51175 nos. The DAO further informed that under RKVY (RAFTAAR) Sugarcane Cusher distributed till date 43 nos. and power tiller distributed 162 nos. till date. The DAO also informed that under BGREI Scheme paddy thresher distributed 20 nos. and power tiller distributed till 110 nos. till date and power tiller target 95 nos. for the year 2021-22. The DAO further informed that under NFSM power tiller and HP Electrical Motor distributed 120 nos. and 60 nos. till date respectively and power tiller target for the year 2021-22 20 nos. He also informed that 355.83 MTS paddy procured in this season and 199 nos. of farmer certificate has been provided to the MP Kisan beneficiaries.

**AGRICULTURE ENGINEERING :** The Asstt. Executive Engineer, Agriculture, Golaghat informed that selection of beneficiary for distribution of Mini Truck @ 30% subsidy has been

done and farmers share are being collected. The AEE also informed that application collection is going for distribution of Mini Rice Mill @ 30% Govt. Subsidy. He also informed that under RKVY 2019-20 (RAFTER) construction of 100 MT Godown is going on and the progress is 90%. He further informed that under RIDF total 1103 nos. of STW has been installed including pump set out of the target 2499 nos. The AEE also informed that under RKVY, 2018-19 and RKVY-2019-20 (RAFTER) (1<sup>st</sup> & 2<sup>nd</sup> Phase) balanced target of power tiller, PTO operated paddy thresher and paddy thresher with prime mover are handed over to the DAO, Golaghat as per instruction received from Directorate of Agriculture. He further informed that under BGREI, 2017-18 construction works of partially covered threshing floor 100% works of 8 nos. out of 9 nos. have been completed and 85% work has been completed rest of 1 no. of scheme.

**WATER RESOURCE :** The Executive Engineer, Water Resource Department, Golaghat informed that the works namely "R/S to Brahmaputra dyke from Negheriting to Rongagorah from Ch.0Km to 23<sup>rd</sup> Km and the scheme namely "R/S to Dhansiri bund from Panjan to Borpathar and Dowel bund at Old Kamargaon including A/E measures at different reaches under NABARD-RIDF-XXV the works are going on and the progress is 87% and 90% respectively. The E.E. also informed that all the works under SDRF for the year 2018-19, 2019-20 and 2020-21 have physically completed. He further informed that the scheme namely "Closing of breach at Ch.2.8 Km R/R & 1<sup>st</sup> Km L/B and strengthening of Kakodonga bund both banks from Borholla to Dhodar Ali under SOPD FDR for the year 2019-20 is going on and over all physical progress is 67%. The E.E. also informed that construction of Guest House of Water Resource Deptt. at Kohora under SOPD- G for the year 2020-21 the works is going on.

**PWD, GOLAGHAT & KHUMTAI/BOKAKHAT/SARUPATHAR TERRITORIAL ROAD DIVISION, PWD (NH-37 AND NH-39)/PWD TERRITORIAL BUILDING DIVISION.**

The Executive Engineer,PWD,Golaghat & Khumtai Territorial Road Division informed that the works under PMGSY Batch -I,II and III for the year 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21 out of 192.78 Km total road length 178.15 Km have already been completed. He also informed that Construction of RCC Bridges under RIDF-XXIII, RIDF-XXIV and RIDF-XXV total 11 nos. of RCC Bridge 10 nos. have been completed. The EE further informed that under SOPD-G w.e.f. 2017-18 to 2021-22 out of total 113 projects (177 nos. of Roads & 1 No. RCC Box Culvert) 108 nos. projects have already been completed.

The Executive Engineer, Sarupathar Territorial Road Division informed that under SOPD(G) for 2020-21 the construction of Tengabari to Kachamari Ali the work rescinded from the original contractor and will be re-allotted soon. He also informed that under PMGSY-II (Batch-I) for the

year 2019-20 the road 1) Road from T26-Chatianil Ali 2) MRL03-Road from Borghoria to Bordubi Gaon via Gelabil 3) the road from Naojan to Ladanasa 4) the road from Sonalipathar to Naojan via Sonalinagar No.1 and 5)the road from NH-39 to Shyanmraipur TE likely to be completed in the Month of Feb/2022. The Deputy Commissioner asked the EE, PWD, Sarupathar to take steps for repairing of Chilanijan Borpathar Road.

The Executive Engineer, NH -39 informed that the scheme namely "Temporary Rectification of Black Spots" out of 11 nos. 10 nos. have already been completed. The D.C. asked the Executive Engineer to take steps for erecting signboards reflecting speed limit from Numaligarh Tini Ali to ASTC Bus Stand, Bokakhat.

The Executive Engineer, PWD(B&NH), informed that construction of Higher Judicial Building at Golaghat 100% works have completed and ready to hand over. He also informed that 68% works have been completed the construction works of ADR Centre at Golaghat . He further informed that konstruktion of Sub-Divisional Judicial Magistrate Court Complex with Residential Quarter , Guest House and other ancillary works at Bokakhat 85% works have been completed and notice served to the contractor to expedite the work. The E.E. further informed that construction of proposed Model High School at Tea Garden area is going on.

**TAXES** : The Assistant Commissioner of Taxes, Golaghat informed that total target for the year 2021-22 Rs. 19078.49 Lakh total collection of Revenue Rs. 13625.76 Lakh upto January/2022. He also informed that during the month of January/2022 Revenue collection was Rs. 13,78,33,580/- . He further informed that efforts are being made to fulfill the target.

**PUBLIC HEALTH ENGINEERING, GOLAGHAT** : The Executive Engineer, PHE, Golaghat informed that land not yet finalized for 1) Janpar PWSS and 2) Golaghat Grant PWSS under Pulibior Gaon Panchayat. In this regard the Deputy Commissioner asked the P.D. DRDA to look into the matter. The D.C. also asked the E.E., PHE both Golaghat and Bokakhat to contact the concerned BDO for land finalization where land not yet finalized.

**EXCISE** : The Superintendent of Excise, Golaghat informed that during the Month of January/2022 total collection of revenue was Rs. 33639537/- He also informed that raids are being continued against the illicit liquor covering the entire district.

**TRANSPORT** : The District Transport Officer, Golaghat informed that during the month of January/2022 total revenue collection was Rs.2,33,18,426/-. He further informed that upto the month of April/2021 to January/2022 achievement of collection of revenue was 71.67% against the target of Rs.26.00 Cr. The DTO also informed that preparation of Road Safety Book has already been completed.

**SERICULTURE** : The Asstt. Director, Sericulture informed that a joint collaboration with NRL a Muga Rearing programme has been conducted successfully at Bogidhola alongwith it a training programme was also conducted which is still in under progress to motivate the young generation to come up with the Muga Silk Worm activities. In this regard the Deputy Commissioner asked the Inspector of Schools, Golaghat to tie up the coming training programme so the more young generation (Students) may come up to join in these training programme. The D.C. also asked the PD, DRDA to tie up the proposed Som Nursery scheme with Sericulture Department.

**IRRIGATION** : The Executive Engineer, Golaghat Sarupathar Irrigation Division informed that up to date physical progress of Rengma FIS under AIBP for the year 2009-10 is 75% and the scheme is targeted to be completed within June/22. The E.E. also informed that under RIDF-XXV(NABARD) Solar Powered MDTW Scheme at Pub Borpathar area (3 Points) 100% works have been completed and the MDTW Scheme at Golaghat LAC (2 points) the physical progress of the scheme is 98% and it is likely to be completed by 15<sup>th</sup> Feb/2022. He further informed that out of 2 points of Solar Power MDTW in Pachim Sarupathar Area one point is completed and the other point is likely to be completed by 15<sup>th</sup> Feb/2022. The E.E. further informed that 138 nos. of proposal for Golaghat LAC and 340 nos. for Sarupathar LAC for Tube Well Scheme under PMKSY-HKKP-Access to ground water from registered Small Marginal Tea Growers have been submitted to Govt.

**HANDLOOM & TEXTILES** : The Superintendent of H&T, Golaghat informed that under Weaver Mudra Loan Scheme 345 nos. of loan application form submitted to the bank with relevant document. He further informed that under SAMARTH training is going on in 2 nos. of training centre. The Supdt. also informed that block level cluster under NHDP 3 nos. of BLC project proposal has been submitted to Govt. He further informed that under "SWA NIRBHAR NARI" scheme under SOPD-G for the year 2021-22 registration of weaver is going on and a list of 20 nos. of PWCS submitted to the Govt. under working capital assistance to PWCS for the year 2021-22. He also informed that construction of Yarn Bank at Bokakhat under Yarn Bank Scheme implemented by ARTFED has been completed.

**HEALTH SERVICES** : The Joint Director, Health Services, Golaghat informed that Routing Immunization of Children is going on smoothly. The Joint Director also informed that during the month of January/2022 total blood collection and examination was 5842 nos. He further informed that during the month of January/2022 total fever case was received 6831 nos. He also informed that under NLE Programme 13 nos. of cases getting MDT treatment. The Joint Director also informed that during the month of Jan/2022 total Truenat Test was done 19 nos. and total MTB detected 2 nos. The J.D. also informed that under National Tobacco Control Programme (NTCP) 5(five) nos. of awareness meeting were conducted during the Month of January/2022 at Golaghat Hindi School, Bengoli School, Dolowjan TE, Betioni High School and Nogora High School. The Joint Director also informed that upto the month of April/2020 to January/2022 total 1371 nos. of card issued under ATAL AMRIT ABHIJAN.

**SOCIAL WELFARE :** The meeting discussed on NRC referral of SAM Children and enrolment of beneficiary in poshan tracker app. and MRP comparison and also PMMVY/SNP scheme.

**APDCL :** While discussing on APDCL sector the C.E.O. APDCL requested the heads of development department to include the electricity bill amount and to mark a copy to the APDCL Authority, Golaghat while submitting the Annual Budget to the Govt.

**VETERINERY :** Meeting discussed on the affect of hail storm on Veterinary Sector occurred on 5<sup>th</sup> January/2022 in various places of the District. The D.C. asked the DVO to submit damaged report at an early date. D.C. also asked the DVO to take for improvement of field level reporting system of veterinary sector. The DFO informed that under National Livestock Mission establishment of 10 nos. of backyard goat farms with 10 nos, of SHGs at Golahat, Bokakhat, Dergaon, Sarupathar and Kamarbondha is on process and under Mission Goat Production in Golaghat District covering 3 nos. of villages 800 nos. goats vaccinated. He also informed that under SOPD-G 900 nos. of beneficiaries are targeted in Goat Development Scheme.

**FISHERIES :** The District Fishery Development Officer, Golaghat informed that BDMC formation in 15 nos. of beel fisheries under APART is completed and proposal will be submitted to govt. very shortly. He also informed that one village community tank will be constructed in each revenue villages under CMSGUY and RIAS scheme and accordingly advertisement published in daily news papers inviting applications.

**INDUSTRIES & COMMERCE :** The representative from DI&CC, Golaghat informed that under PMEGP scheme total 245 nos. of application have been received and forwarded after scrutiny 196 nos. and application returned after scrutiny 49 nos. He also informed that 47 nos. of proposal has been sanctioned and out of which 17 nos. have been disbursed. The D.C. asked the GM to submit a status report on International Agor Trade Centre at Dabidubi.

**SOIL CONSERVATION :** The Divisional Officer, Soil Conservation Department informed that under RIDF-XXV -2019-20, XXV-2020-21 and 20200-21 the scheme namely 1) Antil-erosion cum water conservation measures at Amguri 2) Dhodang Water Harvesting & Land Development Project and Nature Conservation and beautification scheme at Ahotguri Satra, Koroini Bhakatgaon the work is going on and the progress is 80%, 90% and 100% respectively. The DO also informed that protective afforestation with boundary fencing at NO.1 Buragohainkhat, Morangi for the year 2020-21 and at Bokial, Morangi is going on and the progress is 60% and 70% respectively.

**TOWN & COUNTRY PLANNING :** The DY. Director, T&CP, Golaghat gave a briefing on the progress and achievement of CIDF Scheme under Golaghat Town. He also informed that the scheme under Urban Water Supply Distribution System at Golaghat Town scheme not yet handed over by AUWSB and reminder sent by CE(T) to MD, AUWSSB.

**SECONDARY EDUCATION/ELEMENTARY EDUCATION** : The Inspector of Schools, Golaghat and i/c DEEO, Golaghat informed that the works under Major Repair, Boys Toilet and DYSF Girls Toilet for the year 2020-21 has already been completed. He also informed that construction 1(one) no. Girls Toilet for the year 2020-21 not started due to zero enrolment. The I.S. further informed that construction of ACR for the year 2019-20 has already been completed and repair of CM relief fund for the year 2020-21 and ACR for the year 2020-21 works are in progress. The I.S. also informed that Civil Works for the year 2018-19 of 2 nos. of school works stopped due to 3<sup>rd</sup> installment of fund not received. He further informed that construction of Toilet works for the year 2018-19 of 2 nos. of school and for the year 2020-21 of 2 no. of school has been completed.

Summing up the discussion the Deputy Commissioner informed that the next DDC meeting for the month of March/ 2022 will be held on 5<sup>th</sup> March/2022.
