**Order under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023**  
**Subject: Prohibitory order in connection with National Eligibility cum Entrance Test (NEET)**  
**Examination**

Whereas, to ensure utmost transparency in the Written Examination for National Eligibility cum Entrance Test (NEET) conducted by National Testing Agency (NTA) to be held on 4<sup>th</sup> May, 2025;

Whereas, it is requested to issue order under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 to prohibit the entry of any person other than the candidates and officials engaged for conduct and monitoring of Examination on the day of NEET examinations in and around 100 meters of Examination centres; **PM SHRI Kendriya Vidyalaya, Golaghat and PM SHRI School Jawahar Navodaya Vidyalaya, Golaghat.**

Whereas, there is an apprehension of breach of peace and public tranquillity due to large gathering of candidates and their guardians/well wishers around the Examination centres;

Now, therefore, in exercise of the powers conferred upon me under Section 163 of the **Bharatiya Nagarik Suraksha Sanhita, 2023 (B.N.S.S)**, I, Shri Pulak Mahanta, ACS, District Magistrate, Golaghat, do hereby orders the following throughout the district of Golaghat:

- ***Entry of unauthorized persons or unnecessary crowd around the premises of Examination Centers and within 100 meters radius of the centre premises.***
- ***Entry of unauthorized persons inside the premises of Examination Centres.***
- ***Assembly of three or more persons except candidates and authorized persons within 100 metre radius of Examination Centre.***
- ***Authorised persons engaged in the conduct of examination aiding students/ examinees through unfair means.***
- ***Carrying of any unauthorized & suspected objects, Mobiles phones, Smart watch, Calculator, Electronic Devices by the examinees to the Examination Hall.***
- ***Carrying of any weapon, explosives or any other suspicious objects within 100 metre radius of Examination Centres.***
- ***Obstruction of traffic and illegal parking of unauthorized vehicles within 100 metre radius of Examination Centres.***

- **Using Loudspeakers/high decibel sound producing instrument within 200 metre radius of Examination Centres.**

This order will come into force with immediate effect and will remain in force until completion of examination.

Any person aggrieved by this order may approach the undersigned for exemption/alteration etc. of this order.

The Superintendent of Police, Golaghat will get these orders implemented in letter and spirit.

In view of the emergent situation this order is passed ex-parte and addressed to the public in general.

In the event of any violation of this prohibitory order, action shall have to be taken against the violators U/S 223 of the Bharatiya Nyaya Sanhita, 2023.
