ORDER

Whereas; reports received from the Sr. Superintendent of Police, Golaghat and from the Circle Officer, Morongi Revenue Circle, Golaghat Vide No. MRC.04.2019/Pt-1/778 dated 5th September 2025 regarding declaration of Assam Bio Ethanol Pvt. Ltd & Numaligarh Refinery Ltd. Dist-Golaghat, Assam as "**Protected Area**".

Whereas; it has been made to appear to me that in the greater interest and in the interest of safety and security, it is extremely expedient to take and ensure special precautions in order to regulate entry of unauthorized persons into the area specified in the schedule below except, bonafide Servants/ employees of the Assam Bio Ethanol Pvt. Ltd & Numaligarh Refinery Ltd. Dist-Golaghat and other offices attached thereto with or without arms and ammunitions explosive substances and weapons of any nature , either in vehicle or by any other means of transport or otherwise and having been satisfied on such expediency.

Therefore, I, Shri Pulak Mahanta, ACS, District Magistrate, Golaghat, in exercise of powers conferred upon me under section 2 of Assam Maintenance of Public Order, 1947, do hereby order and declare the Schedule Area as "**PROTECTED AREA**" with immediate effect and until further order of modification / cancellation / revocation or withdrawal.

And no person or group of persons shall except the bonafide residents and servants/employees of Assam Bio Ethanol Pvt. Ltd & Numaligarh Refinery Ltd. Dist-Golaghat, as mentioned in the para above, enter into or stay on or pass over or loiter in or around the scheduled area or in the vicinity thereof, without prior permission from the undersigned or any other Officer duly authorized or the Senior Superintendent of Police, Golaghat or any other Officer duly authorized by them or Assam Bio Ethanol Pvt. Ltd & Numaligarh Refinery Ltd. Dist-Golaghat, Golaghat.
