ORDER

Whereas a proposal vide Letter No. IGGL/JOR/GNPL/SV-16/2024/07, dated 05.12.2025 received from the Manager, Indradhanus Gas Grid Limited (IGGL), Jorhat-785101, Assam, for declaration of a Prohibited Zone around the Sectionalizing Valve Station (SV Station)-16 at Kanfola Sapori Gaon under Khumtai Revenue Circle, Golaghat, has been examined;

And whereas verification reports have been received from—(i) the Senior Superintendent of Police, Golaghat vide No. GLT/DSB/70(S)/2025/909, dated 03.12.2025; and (ii) the Circle Officer, Khumtai Revenue Circle vide No. KRC.02/2014/Misc/P-III/616, dated 20.08.2025;

And whereas the said installation has been reported to be of vital importance;

And whereas the area falls within the criteria laid down under Section 2, sub-section (8) of the Official Secrets Act, 1923;

Now, therefore, I, Shri Pulak Mahanta, ACS, District Magistrate & District Commissioner, Golaghat, in exercise of the powers conferred under the provisions of the Official Secrets Act, 1923, hereby declare the **area around the Sectionalizing Valve Station (SV Station)-16 at Kanfola Sapori Gaon under Khumtai Revenue Circle, Golaghat, as a PROHIBITED AREA**, with immediate effect.

All concerned authorities will ensure due compliance of this order.

The Sr. Superintendent of Police, Golaghat shall take necessary steps for enforcement and security arrangements as per law.
