Order under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 Subject: Prohibition of Traffic on Eroded Segment of Toranichuk Road

Whereas, dangerous condition caused by the erosion of the road segment at the 2nd kilometer of Toranichuk Road by the River Ghiladhari, it has become necessary to take immediate action to ensure public safety and prevent any untoward incidents;

Whereas, in light of the such conditions of the road, communicating through it may cause unwarranted risk to human life and safety.

And whereas, it is necessary to control the aforesaid activities issue and directions to the concerned persons in the interest of the purported class of human beings.

Now, therefore, in exercise of the powers conferred upon me under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (B.N.S.S), I, Dr. P. Uday Praveen, IAS, District Magistrate, Golaghat, do hereby orders the following with immediate effect:

- Prohibition of Traffic: All vehicular and pedestrian traffic is strictly prohibited on Toranichuk Road from its starting point up to the 2nd kilometer, where the erosion has occurred.
- Closure of Toranichuk Road: The said road segment is to be closed with immediate effect under the jurisdiction of Golaghat district.
- Alternative Route: Commuters will use the Ghiladhari Nabamilan Road as an alternative route for travel.

This order will come into force with immediate effect and will remain in force till 04.09.2024 or until further orders, whichever is earlier.

Any person aggrieved by this order may approach the undersigned for exemption/alteration etc. of this order.

The Superintendent of Police, Golaghat will get these orders implemented in letter and spirit.

In view of the emergent situation this order is passed ex-parte and addressed to the public in general.

Any violation of these order shall be liable to be prosecuted under the relevant provisions of the Bharatiya Nagarik Suraksha Sanhita, 2023.
