PROHIBITORY ORDER

U/S 163 BNSS,2023

Whereas, it has been made to appear to me that some organizations / individuals have deliberately violated the Rules / Guidelines/Directives subsequently issued by the Hon'ble Supreme Court of India/Government/District Administration related to the Noise Pollution by playing high volume loud speakers, amplified music, bursting fire crackers etc. beyond 10.00 PM;

And whereas, in my opinion, such use of high intensity sound has negative impact on the students preparing for various examinations;

And whereas, necessary directions have already been strictly issued to all the event organizing committees/individuals to restrict the sound level beyond 10.00PM as per the directions of Hon'ble Supreme Court of India;

And whereas, such act of violation of Noise Pollution Rules/Guidelines/Directives in amounting to hamper/disrupt of the environment as well as human well-being;

And whereas, right to healthy environment under Article 21 enshrined in the constitution of India is a Fundamental Right of all living being;

Considering such facts and circumstances, I Shri Pulak Mahanta, ACS, District Magistrate, Golaghat, in exercise of power U/S 163 BNSS, 2023 do hereby promulgate the following prohibitory order throughout the district of Golaghat.

- ***Use of loudspeakers without proper approval / permission from the District Administration.***
- ***Playing of any kind of high-volume loudspeakers, amplified music, or bursting of firecrackers beyond 10:00 PM.***
- ***Cumulative noise from all sources exceeding 55 dB during daytime and 45 dB at night in residential areas.***
- ***Use of loudspeakers at high volumes near hospitals, offices/courts in session, educational institutions, etc.***

In view of emergent nature of situation, this order is passed ex-parte U/S 163 BNSS, 2023.

The Senior Superintendent of Police, Golaghat will get these orders implemented in letter and spirit.

The Addl. District Magistrate cum Co-District Commissioner, Dergaon, Sarupathar & Bokakhat Co- District, Golaghat are hereby authorised to issue any relaxation / addition to this order depending upon the necessity of the situation in their respective jurisdiction.

This order will come into force with immediate effect and will remain in force until further order.

Any person aggrieved by this order may approach the undersigned for exemption/alteration etc. of this order.

Any violation of this order will invite prosecution U/S 223 of Bharatiya Nyaya Sanhita, 2023.
