No. RLA. 177/2021/3.- In pursuance to Cabinet decision dated 12/01/2022, Assam Gazette No. 178 Dispur, Friday, 11th March/2022 and Managing Director letter No. AUIDFCL/19/2024/214, dated:-28/02/2024, the District Level Land Purchase committee (DLLPC), Golaghat, after being satisfied that for the public purpose, the land, the brief description of which is given in the Schedule below, is required for the acquisition of land for construction of approach road to proposed Water Treatment Plant of Golaghat Town water supply scheme under Assam Urban Sector Development Project funded by Asian Development Bank, hereby declares its intention to acquire such land by direct purchase. Any person interested in the said land may, within 1 (one) month from the date of publication of this notification, object to the use of such land for the aforesaid purpose under para 4.6 of the said notification. Every such objection shall be made to the Chairman, DLLPC, Golaghat namely, DISTRICT COMMISSIONER/ DISTRICT COLLECTOR in writing and shall set out the grounds thereof and the Chairman, DLLPC shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objections and after making such further enquiry, if any, as the Chairman, DLLPC thinks necessary, by order, either allow or disallow the objections. This notification is published for acquisition of land through direct purchase through negotiated settlement for improvement and upgradation of State Highways and major district roads under Asom Mala project. The land plans and other details of the land to be acquired under this notification are available and can be inspected by the interested person at the <https://golaghat.assam.gov.in>, concerned Revenue Circle Office and office of the Chairman, DLLPC cum District Commissioner, Golaghat.
